**RESPONSE TO ANY AND  
ALL MOTIONS TO  
DISMISS OR SUMMARY  
JUDGMENT RELATING  
TO THIS CASE**

23 Comes now the Plaintiff, representing himself and those being tortured with intent to be  
24 deprived of life and can not speak in their own defense. **WHAT MUST I DO TO GET**  
25 **RIGHTEOUS AUTHORITIES IN THIS REGION TO INVESTIGATE RIGHT**  
26 **AWAY?! I battle death every day trying desperately to stay alive long enough to testify**  
27 and present the evidence I've gathered TO SAVE LIVES FROM INHUMANE  
28 TORTURE AND DEATH! To be blatant local authorities probably don't possess  
29 enough medical knowledge to see the proof I've already submitted and besides some of  
30 them have only added to crimes against my wife and I! **KNOWLEDGEABLE**  
31 **FEDERAL INVESTIGATORS WITH MEDICAL EXPERTS NEED TO**  
32 **INVESTIGATE MY ALLEGATIONS RIGHT AWAY!** This is the main reason of my  
33 complaint. **PEOPLE ARE BEING MURDERED RIGHT UNDER OUR NOSES IN**  
34 **OUR HOSPITALS AND IN OUR MENTAL WARDS!!! AND NO MATTER HOW**

35 HARD I'VE FOUGHT TO GET OFF MY DEATH BED AND SPEND EVERY  
36 WAKING MOMENT TRYING TO GET SOME RIGHTEOUS AUTHORITES TO  
37 INVESTIGATE NO ONE COMES!!!! I am seriously ill, I don't have the strength to  
38 handle all the paperwork generated from attorneys in an effort to attempt to disregard the  
39 seriousness of the material facts! I do have the strength to testify, to present evidence  
40 proving my allegations in Court. I would appreciate help, because there is a lot of  
41 technical evidence. I'm going to need to summon other witnesses that I don't even know  
42 their names yet but can be obtained by subpoenas of employment records and from eye  
43 witnesses. I can scientifically, prove my allegations concerning the aspects of the  
44 medical mis-diagnosis and lack of diagnosis that is depriving me of my life and resources  
45 in an attempt to cover up serious organized criminal activity and corruption.

47 With that introduction, it is obvious that anyone filing a motion to dismiss or for  
48 summary judgment is in contention with the allegations of my complaint. Plaintiff argues  
49 that the allegations of criminal activity are of such a serious nature that it simply would  
50 be summarily sentencing to death and torture unknown innocents and probably result in  
51 my own unjustly. I HAVE SACRIFIED EVERYTHING TO FILE THIS COMPLAINT,  
52 AS I'VE LOST MY ABILITY TO PROVIDE FOR MYSELF, MY WIFE, AND WAS  
53 ON THE VERGE OF FORECLOSURE AND POSSIBLE HOMELESSNESS, WHICH  
54 IS A VIRTUAL DEATH SENTENCE IN MY PRESENT STATE OF HEALTH. I  
55 URGE THE COURT TO PLEASE EXPEDITE A COURT DATE BEFORE THAT  
56 HAPPENS! Besides trying desperately to defend myself, so that I can rest from the  
57 homicidal attempts on my life and try to regain my health or at least spend my final days

58 not having to face dying homeless with a defaming mis-diagnosis. Some might think,  
59 I'm not suffering, in order to have attempted to file this complaint. ON THE  
60 CONTRARY, the excruciating present suffering every waking moment, won't let me rest  
61 well, as I know I may be a rare survivor of heinous activities being perpetrated on  
62 unsuspecting American citizens by intelligent, organized criminals taking advantage of  
63 public trust. MAKE NO MISTAKE, THIS COMPLAINT IS A MATTER OF LIFE  
64 AND DEATH! My allegations are truthful, the government is negligent at best and a  
65 willing participant at worst; as no matter how hard I've tried, no serious investigation has  
66 been conducted and I have to endure every day, GENUINELY AND DEEPLY  
67 CONCERNED, that the awful pain I'm experiencing could be done to someone else,  
68 while I scream as best I can for assistance to stop this inhumane criminal activity. VERY  
69 SUSPICIOUS, acts have occurred since I started trying to get authorities to investigate  
70 my allegations, some local authorities have committed more serious crimes, but the most  
71 frustrating is that there are federal employees, through use of the Patriot Act, who  
72 working with local authorities know I'm telling the truth about these things and have  
73 done their best to discredit and spread lies about me, rather than HELP ME SAVE  
74 LIVES. Word has gotten back to me that authorities have been telling others I'm a drug  
75 dealer, and still others going around to potential witnesses telling them I'm some kind of  
76 terrorist! I have literally sent hundreds of faxes and emails to authorities and other  
77 persons who could reach authorities in their area on various levels, simply trying  
78 desperately to get knowledgeable and righteous ones here, because some of the criminals  
79 must be rogue agents and law enforcement officers that are taking advantage of public  
80 trust to perpetrate these crimes even like these physicians we honor simply because we

81 must trust them with our very lives and welfare. I state again, when allegations are this  
82 serious, to summarily dismiss the case is to be sentencing innocent suffering citizens to  
83 ongoing torture and death, when I may be one of the rare survivors that can help put a  
84 stop to it. PLEASE HELP ME BY CALLING IN MEDICAL EXPERT FEDERAL  
85 AUTHORITIES SO THAT I CAN SUBMIT THE TECHNICAL EVIDENCE AND PUT  
86 A STOP TO THESE KINDS OF ATROCITIES BEFORE THEY MURDER OR  
87 TORTURE EVEN MORE! TIME IS OF THE ESSENCE! PLEASE HELP ME! I only  
88 filed the complaint, because after nearly a year of attempting to get local, state, and  
89 federal authorities to take my faxed affidavit seriously enough to come knock on my  
90 door, so I could show and explain the evidence NO ONE DID! THIS IS SERIOUS! I'M  
91 NOT MAKING IT UP! IT'S NOT IN MY HEAD! I personally met victims of  
92 "medical mal-practice" testify that not only in this state but others where "medical  
93 malpractice" occurs, they shuffle some of the rare survivors of the willful crimes, into  
94 mental wards, where they are given psychotropics and they either go along with the  
95 conspirators and agree the "malpractice" never happened or they get shuffled off to state  
96 institutions where the medications and dosages bring about their early deaths or they  
97 suffer other terrible crimes of various assaults, and cruel and unusual treatment. NO  
98 ONE SHOULD BE FORCED TO TAKE MEDICATIONS THAT CARRY LETHAL  
99 WARNINGS!!!!!! But it's a standard of practice, even though it causes serious internal  
100 injuries and early deaths short of a miracle from GOD. Not only is our government  
101 actively involved in much of these allegations, but is at best negligent and I can prove  
102 that as a matter of law. (BECAUSE MY ALLEGATIONS ARE FACTUAL)

104 Another reason I filed was that, since some federal and local officials are involved in the  
105 crimes and have knowledge of the crimes against me, I wasn't sure from the lack of  
106 response from any of the higher authorities to come and investigate, that my pleas were  
107 even getting to them. I included them in the complaint; so that I would know for sure  
108 that various aspects of our executive branch in charge of law enforcement absolutely  
109 were notified that SERIOUS CRIMES ARE BEING PERPETRATED AGAINST  
110 CITIZENS BY MEDICAL PRACTITIONERS (WHO ARE TAKING ADVANTAGE  
111 OF PUBLIC TRUST AND LACK OF KNOWLEDGE TO ROUTINELY GET AWAY  
112 WITH IT) AND EVEN BY CERTAIN CORRUPT AUTHORITIES WHO KNOW IT'S  
113 GOING ON BUT ARE NOT DOING ANYTHING TO STOP IT! So I actually was  
114 anticipating, instead of paperwork, that state or federal authorities would be arriving to  
115 investigate my criminal allegations, shortly after filing and still none have. I AM  
116 LITERALLY FIGHTING EVERY DAY TO STAY ALIVE LONG ENOUGH TO  
117 TESTIFY AND PRESENT THE EVIDENCE. MY HEALTH CHALLENGES AND  
118 EXTREME PAIN IS MAKING IT INCREASINGLY DIFFICULT TO  
119 CONCENTRATE AND PRESENT COMPETENTLY WHAT I KNOW I CAN PROVE  
120 IF GIVEN THE OPPORTUNITY AND SOME ASSISTANCE FROM THOSE WHO  
121 KNOW I'M TELLING THE TRUTH. I can individually and scientifically prove, my  
122 true ailment(s) in Court, that I could get medical help for but I need resources in order to  
123 do so. I have sacrificed my energy and effort and personal resources that should be spent  
124 resting, attempting to get healthy, because my conscience can't suffer that the agony I'm  
125 experiencing could be happening to someone else and more souls murdered simply  
126 because I've been unable to get anyone to take this seriously! After many hours of

127 research I am convinced that the genetic trait being called “Wilson’s Disease” affects far  
128 more people than AIDS and yet the public and medical fields are woefully uninformed on  
129 how to recognize it. A genetic condition that affects so many (MULTI MILLIONS ARE  
130 SUFFERING AND ARE BEING INTENTIONALLY KEPT IN IGNORANCE), has  
131 been known of for at least a century and yet is wrongfully considered rare and so few  
132 know how to recognize even though it results in all manner of serious ailments; EVEN  
133 TERMINAL CONDITIONS, (profitable to the medical field and pharmaceutical  
134 industries) MUST be known about by certain individuals in our government, but no one  
135 is informing the public even remotely to the same degree as AIDS. Willful profiteering  
136 off the ignorance of the public at worst and negligence at best is causing mass millions  
137 (perhaps hundreds of millions globally) to suffer and often they are being told their pain  
138 or symptoms are all in their head (which is unbelievably cruel), due to this fact. PLEASE  
139 HELP ME RIGHT AWAY! Call in the FBI or federal marshals with medical and  
140 forensic experts. Who knows how many have been murdered during the time since my  
141 attacks!? Again, it is probably very rare that someone survives the homicide attempt I  
142 have, and I suspect assassination attempts by poisonings afterward to silence me (I have  
143 saved hair and urine samples for testing over the past several years to verify), and  
144 probably rarer still that someone who survives possesses the overall experiential  
145 knowledge to understand what is going on and why and to present the evidence to the  
146 public in a way that can be understood by the populace at large. THIS IS SERIOUS! I  
147 HAVE SURVIVED DESPITE ATTEMPTS TO SILENCE ME BECAUSE THE  
148 PERPETRATORS DON’T WANT THE PUBLIC TO KNOW THE TRUTH HOW  
149 THEY’VE BEEN EXPLOITING THEM FOR SO LONG!!!!

150 (Some might ask why haven't I gone straight to criminal investigators with all the  
151 evidence, keep in mind months at times went by when I was too ill to travel into town  
152 minutes away! I have desperately tried to get them to come here, because when I notified  
153 the local authorities, they all made excuses as to why they couldn't, wouldn't or were  
154 unable to assist me (and some took my complaint as motivation to perpetrate more crimes  
155 against my wife and I, which is another reason I've been trying desperately to bring in  
156 higher, more knowledgeable authorities to investigate)) PLEASE HELP ME TO HELP  
157 OTHERS AND SET A COURT DATE AS SOON AS POSSIBLE. Some days I think I  
158 may be getting better and others I'm not so sure as my life force seems to continue to  
159 wane; especially due to the unwarranted stress of these circumstances that shouldn't exist  
160 but have on account of extreme greed and corruption now permeating into positions of  
161 public trust so pervasively as to put citizens in grave peril.

163 I conclude that in order for matters of disputed facts to be determined by the Court there  
164 must be a trial as provided by the United States Constitution. To summarily dismiss this  
165 legitimate complaint would be a direct violation of the highest laws of our land, as it is  
166 my constitutional right to not be deprived of my life... without due process of law (which  
167 is occurring) and to redress grievances, present evidence, summon and examine witnesses  
168 as a matter of law. Any lesser rules of procedure that have been adopted to prevent the  
169 weighty matters of this complaint from being heard at trial by jury is in violation of the  
170 higher laws that afford citizens these humanitarian and civil rights protections under the  
171 Bill of Rights.

173 Therefore, please refer my criminal allegations of this complaint to the proper authorities  
174 immediately and do not dismiss civil remedies requested because it is unjust that I should  
175 perish in agony, homeless and other innocent citizens unable to defend themselves suffer  
176 torture and possible death at the hands of these persons who taking advantage of their  
177 positions of public trust are committing some of the most grievous crimes.
