

Dear Deborah, Sarah, Mishnah, Aholibah and all Daughters of the Faith:

I mean no disrespect by addressing you by first name. I understand people work very hard for titles, but I believe it only distances us from compassionately caring about every soul equally and it makes me very uncomfortable for those who cherish class social structure. I am suffering immeasurably due to the facts in the attached pdf file. But even more so to the truth of all that has transpired in my recent past. I suffered a terrible homicide attempt at a local hospital that left me with temporary amnesia. When I remembered the events I immediately typed an affidavit and sent it to local authorities. What I didn't realize was that I was still suffering from partial amnesia. I couldn't understand why my wife wasn't helping me get the people who tried to murder me at the hospital arrested. I couldn't understand why she hadn't at least tried to hire an attorney and sue for malpractice even if she didn't believe the homicide attempts when I had suffered two cardiac arrests and flatlined twice once for 5 minutes and another for three or that was what the staff told my wife at the time who relayed it to me. I remember the two incidents but didn't know how long I was without oxygen to the brain until she told me. When I tried to recover at home, I started becoming so violently ill after the homicide attempts at the hospital that I could no longer work (keep in mind I had amnesia and didn't remember the details of the attempts until almost two years had transpired). When I remembered I immediately tried to report the crimes and not so much as a phone call took place to investigate. Instead, I actually started to get followed by police and government vehicles. Now that I remember, I don't believe I'll ever forget the sadistic jerk who laughed at me as I was suffocating to death. My marriage began to suffer when my wife refused to help me or confirm to colleagues, associates and friends that the two separate episodes had occurred. Unbelievably she started telling friends, family and colleagues that I was having a nervous breakdown behind my back. To my horror, this caused some friends to think they were doing a good thing by tricking me into a mental ward. What I didn't know was that my wife had encouraged it and had then lied to the staff at the mental ward stating she was afraid of me. The nightmare of all this is that my memory finally started coming back in full after all these things took place. I filed a suit because of the negligence on a local, state and federal level to investigate when I have medical scientific proof that I'm telling the truth and the hospitals are lying. The most horrible thing about all of this was that the strain on my marriage resulted in separation and during which time I discovered many of the local authorities were having sex with my wife (we were not divorced). This really concerned me because I had met a couple men in my past that had claimed cops had coerced their wives to rob them of their estates and put them in prison on trumped up charges. In great anguish I started praying to GOD asking him what was going on. I then started having horrible nightmares. I saw my wife sitting in a chair at the hospital talking to my surgeon Dr. Cruz and the anesthesiologist Dr. Joy the two doctors were confronting her saying they had discovered why I was feeling so horrible at the young age of 36 and that she could go to prison for the rest of her life for poisoning me as attempted homicide was very serious. I saw in my dream that she started crying as they coerced her into telling them the details of our estate and life insurance policies. Then they said now, now don't cry he (referring to me) is probably an abusive husband right? And she doing her best bawling act agreed and they then said for the right price they could solve her problem (referring to murdering me). And she stopped crying almost instantly and asked how much? they replied that they didn't want to trigger an IRS audit so that for \$50,000 each of the policy when it paid they would do it (murder me) (she didn't even ask if it would hurt me or how they would do it) she simply replied, "DO IT!" I then saw in my nightmares the events that followed and why she wasn't around when I was in critical care following the two attempts. the nightmare went that the two murderers had pulled her into a room and said that I didn't die

easy and that she still owed them the money for taking the risk. she asked them what she should do, and they said that for right now she better go to my bedside and pretend to be a loving, caring wife lest I grew suspicious. I had further nightmares that the reason I started becoming even more ill after returning home from the hospital was that the greedy physicians had been pressuring her to pay up and so she had started poisoning me again. And that was the real reason she had betrayed me by lying at the mental ward and that was why she hadn't hired an attorney to sue the hospital(s) was that she was covering up her crimes! WORSE, I saw the nightmares explain why the cops were having sex with her. Lehman and another officer had gone over to her residence shortly after we were separated and threatened to kill me unless she had sex with them, but to my horror she replied now boys there's no need for that come right in! And then orgies with her and the police department(s) took place. I then had further nightmares revealing to me what was going on, was that one of them forced her at gun point to choose one of them or she would have to be continuously raped (because they actually knew she had tried to poison me and conspire with the physicians but one of them wanted a shot at my estate and so plotted with her to cover up her crimes and the deal was Knaggs called the physicians bribing her and got them to stop). So I was left dying in my home perplexed as to why I had seen cops and federal undercovers driving to and from my wife's house, why all the hushed phone calls and all the while, it's MASSIVE GREED and CORRUPTION! I then remembered my wife used to threaten me continuously during even minor arguments that she could murder me and get away with it. That she was very powerful and that I didn't know what she was capable of and that no one would believe me, they would believe her if it ever came to testimony between us. I also remembered moving into our house and discovering we had mice getting into our garage; so I went to the local hardware store in Spirit Lake and purchased a big box of D-con. I checked the box the next day and discovered it was empty and figured we had an infestation in our brand new home! So I went and purchased some more. My wife made the comment asking where did I get this poison and I asked why she was surprised about it. And she said that it was unusual to still find rat poison undyed as poison was rather a common way to murder someone. I asked how she knew that and she said she had dated a male nurse who worked at some hospital ward and stated an unusual amount of people that most thought died of natural causes was really by poison and was why they had to start putting dye in the rat poison as it was too easy to murder someone with it. I was working 40-60 hours a week at the time and going to school full time at night and not getting much sleep and I really loved my wife so I didn't think anything of it when I came home early shortly thereafter because a prof had canceled a class and found something boiling on the stove. The reason why I distinctly remember it was that my wife didn't cook, I did and she did the clean up. Anyway, I immediately noticed something boiling on the stove and now I realize it was the rat poison pellets but at the time I thought it was some kind of weird aroma therapy as my wife was into Bach flowers and that sort of thing. I was working so hard that I was only getting about three hours of sleep or I might have made the connection. This also all happened just after she had persuaded me into life insurance policies of close to half a million which was a lot of money back then. I now remember although I didn't when I first filed the suit that she had relegated his and her orange juice containers even though it was the exact same brand. I remember that she wouldn't drink from mine or if she found out she had run out and I had poured her some from mine. Because I loved my wife so much and was working so hard to make her happy, it simply didn't occur to me that she would try and murder me. She would sometimes jokingly say things like, you'll leave me for some new model just like all the other men I've known (she's quite a bit older than I am). And I would always reassure her that I loved her and that I would take care of her until she died and went to heaven. I also remember how she would chide me when I told her that next to GOD she was the best thing that ever happened to me and she would say things like, "then you've had a really hard life" and "love is blind" The hard fact for me to face is that my wife tried to murder me by poisoning, then greedy physicians joined in, then raping robbing murdering jerks in uniform disguised as law enforcement thought that they'd take over and I only now have realized that I am truly in danger not only from the fact that I am medically challenged due to the kind of homicide attempts but because all of these people are conspiring against me in order to cover up their unbelievable crimes. I have saved hair and urine sample over the years because I had a background as a medical lab tech and thought that one day I might actually find an expert who could explain to me why I was suffering so greatly and

why no matter how hard I've tried that I have been unable to regain my health. IF YOU KNOW ANY HONEST FEDERAL INVESTIGATORS, PLEASE SEND THEM TO ME HERE IN SANDPOINT, THE LOCAL AND COUNTY OFFICIALS CAN NOT BE TRUSTED! I AM NOT LYING, I WILL TAKE A POLYGRAPH. I KNOW THAT THIS PLACES MY LIFE IN GRAVE PERIL, BUT I CAN NOT DIE WITH A CLEAR CONSCIENCE IF I DON'T TRY AS HARD AS I CAN TO SAVE EVEN ONE OTHER SOUL FROM THE HELL I'VE BEEN PUT THROUGH AND AM STILL GOING THROUGH. I am not strong enough to take care of myself if I should be evicted from my home due to my inability to pay my mortgage. In case, I don't make it, her name is Jane Allyn Swenson, she has gone by Jane Allyn Craig and Jane Allyn Risberg. Two of the cops I know are involved are Lehman and Knaggs and one with a huge head and red hair, but in my nightmares many in the Sandpoint Police Departments and Bonner County and even some from Spokane Washington are involved. MAJOR corruption, and she is either insane or one of the worst psychopaths in history as she has muddied my name all over town in order to cover up her crimes and was having orgies as I've been fighting for my life! Anyway, I recently found evidence that she has been trying to find another sucker as she is falling on financial difficulty that she can talk into a huge life insurance policy and murder for the payment. Same old, same old, it's just that you would never think little miss, "peace be with you" would do so and further you'd never think you'd actually marry someone so cold-blooded. I again mean no disrespect for your education and work; it's just that I believe part of the reason I'm suffering is due to an underlying eugenics philosophy operating within our own government. (1Cor3:13) and "the secrets of his heart made manifest" (showing GOD by His Holy Spirit does reveal unto His people deeds done by others and even their thoughts - 1Cor14:25) and ..."whatsoever does make manifest is light..." (showing that we should not punish whistle blowers because they are only trying to make the world a safer place for others, but I have been punished by people's unbelief and being a rational person, I realize that what has happened to me is so horrible that decent people don't want to acknowledge it. For quite some time I have battled between my great love for my wife (or ex-wife (she told me the divorce was just for financial reasons that she was still spiritually committed but after I signed she celebrated with Knaggs on my stupidity and naïve trust) as the case may be and my concern for other person's safety and the fact that I realize she has done so cleverly as to make my testimony virtually unbelievable even though it is the truth. I also am not mentally ill, I have not imagined any of this it has really happened and an honest investigation would confirm it. I am not so naïve that I don't understand that I am placing my life in grave peril to reveal what I have concluded I must. I have battled my conscience to the point where I realize that what I have to say makes people react with hatred as they cling to a false sense of security in the officials that we give unwarranted trust to. I have been an idealist thinking tax payer dollars actually place people of integrity in uniform when historically and currently nationally and globally we can easily observe that is a fictional presumption of wishful and hopeful fantasy. Nevertheless, to think that there are those who would abuse their offices of public trust leaves the common citizen in such a state of fear and bewilderment that they have systematically disbelieved me at every attempt. So now that I think I have recovered the better part of my memory and even though I have dreams of a future with many inventions I have desired for quite some time to patent, I set forth for the sake of others with the hopes that there will result an honest investigation that will save others from the hell I've endured and unfortunately am still going through. Jane and I moved to Idaho from Colorado in the fall of 1999. She was taking a mixture of antidepressants as the darkness of winter here set in. I reinjured my back shortly after coming here and my relocation business was hit very hard by the weather and a concerted effort to shut out any newcomer to the area. We were forced to file for bankruptcy and

Jane was obviously very stressed. I set about retraining and getting a two year degree. I started working in land sales and going to school full time. I also got my real estate license simultaneously from 2000-2002. During that time she talked me into getting nearly half a million in life insurance policies. I readily agreed that I wanted the "love of my life" to be taken care of should "something happen to me". During this time she kept stating that one day I "would trade her in for a new model". and that she thought I was having an affair with someone at school. I told her I was barely getting three hours of sleep a night and she knew where I was every minute of everyday as we worked in the same building and she had my class schedule. I also told her I would gladly take a polygraph if that would comfort her. That was also about the time the undyed "D-con" rat poison was purchased and the time she started to implement separate beverage containers. keep in mind she is highly intelligent and very persuasive as she has been doing astrological counseling and studying people for many years (she counsels millionaires among her clients) and her smooth "peace be with you" voice wins over unsuspecting persons quite readily. (Of which I was no exception) She used to joke about "men and their dicks" referring to the fact she believed most men could be easily manipulated through their inability to control their sexual appetites. And that she considered that I was an exception and would at times refer to many past liaisons with both men and women. Prior to marriage I asked her if she was a believer in Jesus Christ and if she wanted a faithful marriage as I did. I also asked if her former sinful days (realizing she went through the 60's and disco 70's) were past and she was ready for a life-long committed relationship. She had assured me she was fed up with lying cheating men and that she absolutely valued faithfulness and wanted that in a committed relationship. (So her comments accusing me of infidelity I took seriously) And so I worked extra hard at trying to assure her of my sincere love and commitment. Nevertheless, that was when she started poisoning me by having boiled the D-con and then adding it to my orange juice and other beverages. For the first time in my life I started having migraines and extended bouts of diarrhea, chronic fatigue, muscle spasms and I thought it was all due to my punishing schedule. Immediately after graduation, I went to work with Jane at Sandpoint Realty. I didn't realize then but now I realize she stopped with the separate containers of orange juice when I started making decent money and gave her all my checks (haven't seen a paycheck in years). I worked incessantly trying to keep up with her demands for make-up, clothes, jewelry and her life-long dream of owning horses. I asked her to wait just a little while we acquired cash producing properties first and then she could ride or own horses but not to take money we needed to develop for retirement to spend tens of thousands on gear, tack, trailers, corral, feed and the animals themselves. I further encouraged that we could go for ranch retreats or stables to become skilled riders before we invested our future in the dream. I didn't realize how strongly she felt at the time as I started getting ill again. I kept saying that we were close to her being able to retire while I worked a few more years and then I realized if we managed our assets wisely we could probably semi-retire except for real estate investing. She insisted that there was enough for only one of us to retire (I didn't realize that was EXACTLY what she meant). Furthermore, at intervals during our relationship she would ask me "if I would die for her." Not understanding the phrasing of the question I thought she meant would I fight to the death to protect her, which I readily assured her I would as again at the time I did not realize what she had done and was still

doing to me on and off in her insanity. At times like every couple we would argue about the money. I wanted the tithe to GOD and ministry to come off the top first, Alms to the poor next, investment in our future third and bills last, but unbeknownst to me she wasn't tithing and any offerings I had established to the poor and needy on a monthly basis she was canceling behind my back. In the meantime an incessant stream of shopping products from the television kept coming to our door. So during these arguments about money and how it was utilized she would threaten me stating things like "you don't know what I'm capable of" and "I know how to murder you and get away with it" and "even if I failed, since you have a prior record and I don't, no one would believe you, everyone will believe me instead..." I honestly just thought these were expressions during the heat of the moment kind of like little children that scream "I hate you! I hate you! I hate you! and I wish you were dead!" but they really don't mean it, it's just them throwing a temper tantrum. But I have since realized that comments such as these must be taken very seriously. As opportunistic as I know my wife is (a polite way of saying greedy) I simply could not understand why she didn't hire an attorney while I was fighting for my life after the hospital incident in which they tried to murder me, (but the Lord revealed to me that someone heard the monitors and came running down the hall who wasn't in on the scam and so they were forced to resuscitate me). When I was recovering at home, I actually returned to work for a little while thereafter and thought I was having a successful recovery. But my wife started getting phone calls regularly in which she would cover up and call back (almost like when someone is having an affair and trying to cover it). What I had revealed to me (for the scientifically minded perhaps you'd prefer I have seen things via what is known as "remote viewing" or for the new age minded I have always had what are referred to as ESP, telepathy, de ja vue experiences, but these have been heightened by my many near death experiences now) I however, will give glory to the Creator and Maker of us all who bestows all manner of gifts to the children of men. So I say again, what I had revealed to me was that doctor joy and doctor cruz at deaconess were pressuring her to pay them anyway. So Jane stressed out started covering up where all the money in our accounts was going and poisoning me again. When I was getting so ill I could barely crawl out of bed to go to the bathroom, I desperately started researching on the internet trying to figure out what was wrong with me. When i entered all the symptoms in; the following ailments came up: hepatitis, poisoning, leukemia, and what's considered a rare genetic trait known as Wilson's Disease. Everything in my affidavit is true about the agents and change of hospital staff, I state this realizing that it's easy to patronize someone by coming to the conclusion that perhaps I really do have the trait and then think to themselves that explains his delusions. I have digital images proving I am telling the truth! I am not lying! This is not a hoax! This is not some weird attempt to get attention when all the attention I've gotten has only brought me incredible suffering. **IT IS THE FACT THAT I CAN NOT RUN FROM MY OWN CONSCIENCE AND THAT MY CONSCIENCE BEFORE GOD SIMPLY CAN NOT KEEP THIS GREAT EVIL TO MYSELF WHEN I KNOW IF I DON'T DO EVERYTHING I CAN THESE PEOPLE WILL BE ABLE TO TORTURE AND MURDER OTHERS!!!!!!!!!!** She is so diabolical that she conned my own brother into thinking I had a nervous break down in order to cover up her crimes. She then pandered to public sentiment because I became alarmed when the local authorities did nothing but laugh at me when i informed them of the serious crimes taking place here. **THEY ARE MURDERING PEOPLE!** At NIBH

desperate patients warned me not to buck the system as they had seen people assaulted, sexually assaulted and murdered in our state institutions. So back again to my personal experience. One night during a particularly heated discussion when I found out my wife had intentionally lied to the psychologists at NIBH (once again in order to cover up her crimes) stating that she was afraid of me when I have never hit her or been unfaithful or threatened to hit her since the day we met. Though I have/had dreams of a successful future in which I would bring inventions into the world and declare the knowledge GOD has shared with me to any interested people, I believe this level of evil must be stopped so imperatively that I am literally sacrificing everything and even putting my life in jeopardy to do so. Jane anticipating that her infidelity would cost her (as laws in this state allow for adultery) made certain she giggled to her girlfriends to keep her "affair" with officer Knaggs "between us girls" in order to make this all look like a normal divorce and that she was just like so many today who cheat on their spouses and break their marriage vows when that isn't the case! This is anything but normal adultery! She intentionally screwed a bunch of them, including married ones in

order to keep herself out of prison and because they had threatened to kill us if she told anyone. Knaggs and Lehman had cased our home earlier and her jewelry when my duped brother had called the police one night. I have not committed any crimes but these people have and they are taking advantage of people's undeserved trust in the worst way! My food has been tampered with upon occasion while eating out and one time I almost passed out after drinking some lemonade. My vehicles have been tampered with, my home, my computers, and my dog was shot. Immediately after my dog was shot my wife chided me on the phone, "why won't you learn" as if she had ordered the hit. The very next time I saw her, she said to me, "if you get so sick, you think you have to kill me, please make it quick" **AGAIN I AM NOT LYING! I AM NOT IMAGINING THIS!** During a time I was particularly ill, she invited me over as an attempt to apparently work things out. She gave me gonorrhea. The Lord revealed to me that Knaggs had slept with someone infected and then given it to her but had one of his buddies who was also screwing her take the blame. They did this to try and get me to file for divorce to make it look normal. She is so clever that she waited until I got it and then called me in front of another acquaintance and co-professional and taunted me. I lost it on the phone as my urethra was burning intensely and called her a slut, so she then made sure that the person heard her ask in self-righteous indignation for a divorce. I was simply too ill on top of everything else to fight her in court, beside she assured me privately that she wasn't really asking for a divorce, just legally to protect the majority of our assets and isolate her from legal retaliation as I had chosen to file to get these murderers confined and save other citizens. So she took the best of all our possessions and properties and then threatened me as I struggled for my life on my bed alone except for God. Keep in mind that since I met Jane I have been working so hard trying to keep up with her lifestyle and spending that I have not really socialized with hardly anyone for more than a decade. I state that because when her brother came to visit he pulled me aside not realizing my abilities (as so few ever have because most of the time people are not thinking good thoughts, I have worked hard over the years at not prying and because the few times I revealed I had telepathic abilities people distanced themselves being afraid of me, I can only believe that God hid from me what Jane was doing so I could find out about all the other crimes going on up here and do my best to stop it) And he asked me the same question if i loved his sister and then if i would die for her.
